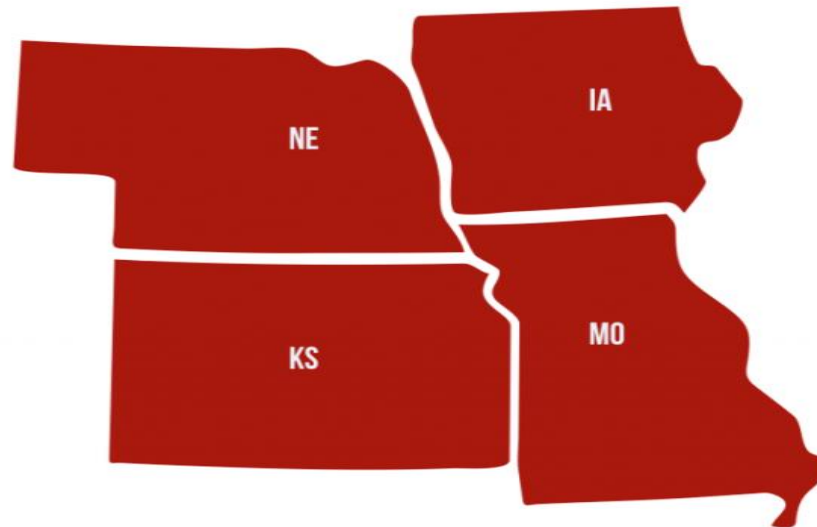

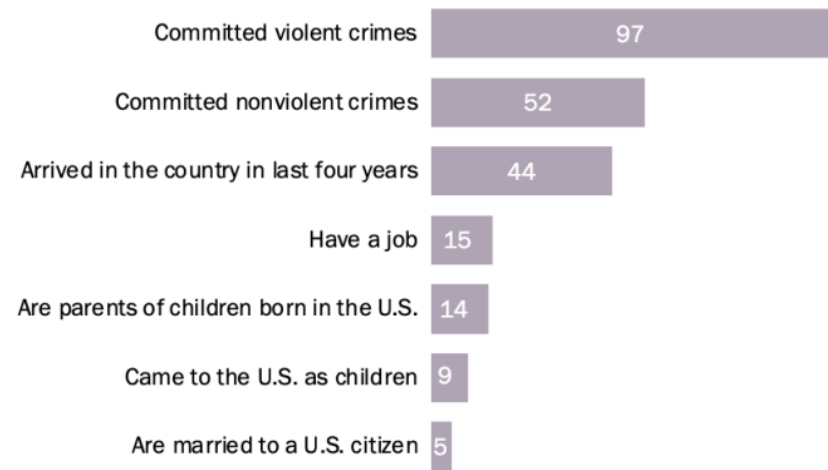
About a third of U.S. adults say all immigrants in the U.S. illegally should be deported; half say some

% who say ___ immigrants living in the U.S. illegally should be deported



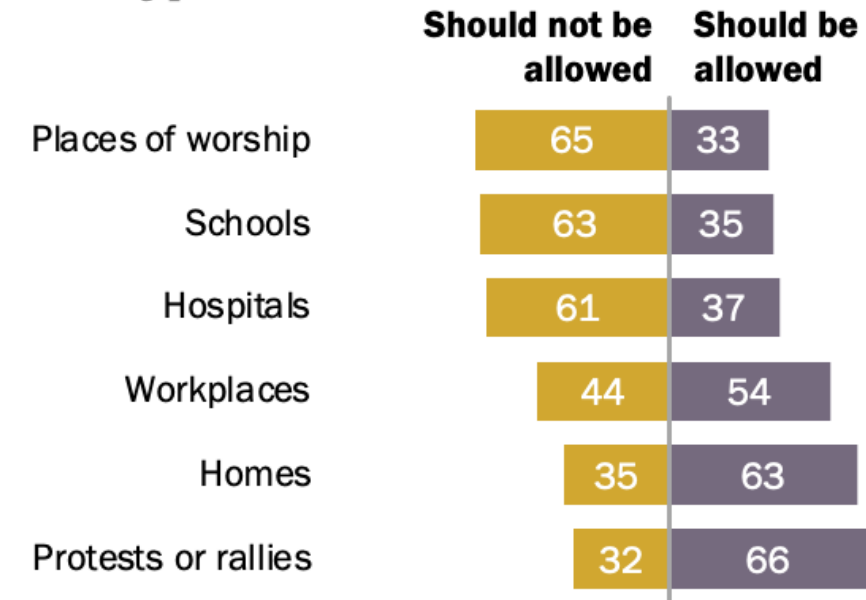
Nearly all who favor deporting 'some' immigrants living in the country illegally say that committing violent crime is grounds for deportation

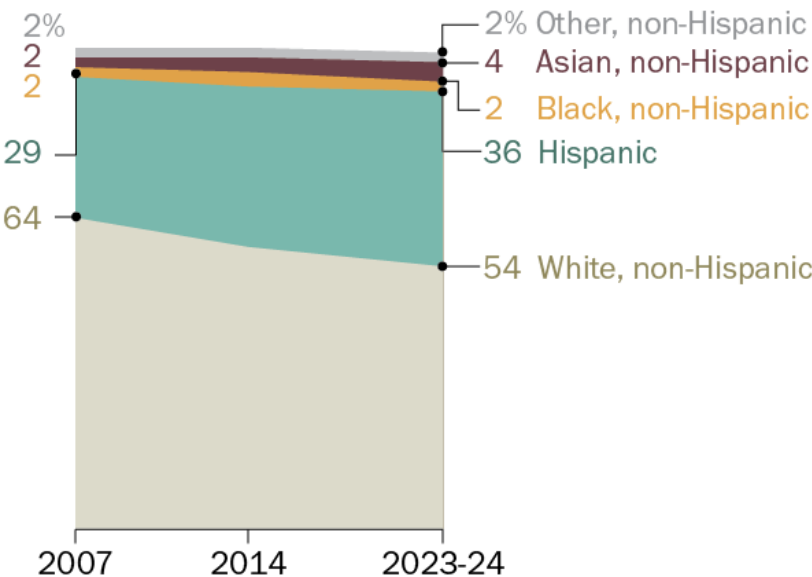

What is Happening on Immigration Policy? An Overview of Federal and State Measures



Immediately, given that some of them require government agencies to undertake additional steps (which can take days, months, or even years). On the other hand, a bill is not immediately effective, but becomes a law after it goes through the full legislative process and is signed by the Governor.

PRESIDENT TRUMP'S EXECUTIVE ACTIONS AND POLICY CHANGES

President Donald Trump has put into effect a series of executive actions on various topics, including immigration. In addition to executive orders, his administration has also announced migration-related policy changes. Here is a summary of some of the most relevant measures:

Executive Order: "Realigning the United States Refugee Admissions Program" indefinitely suspends the admission of refugees in the U.S. through the Refugee Admissions Program. However, it does provide for exceptions to be made by the Department of Homeland Security and the Department of State on a case-by-case basis.

After an election year in which immigration was at the front and center of American political debate, there was substantial speculation about what specific policies would be implemented by the incoming federal and state administrations to address the issue.

February 12, 2025, have been implemented by the federal and state government, as well as of the bills that have been filed in the Missouri House and Senate.

It is important to keep in mind that **an executive action is binding from the moment the president or governor signs the order;** however, that does not mean it will necessarily go into effect.



On January 13, 2025, Mike Kehoe was sworn in as the 59th governor of Missouri. One week later, Donald Trump's inauguration as the 47th U.S. president took place in the nation's capital. Both of them, along with the Missouri General Assembly, have focused on immigration from day one.

LA IGLESIA CATÓLICA ANTE LA MIGRACIÓN: DESMONTANDO MITOS



En medio de una crisis fronteriza de enormes proporciones, el tema de la migración se ha convertido en uno de los asuntos más controversiales del panorama político americano.

Como Madre y Maestra de todos los pueblos, la Iglesia siempre se ha situado a la vanguardia de los esfuerzos por acoger a los inmigrantes que llegan a los Estados Unidos, promoviendo su integración y velando por su protección. No obstante, existen muchas dudas sobre cuál es realmente la postura católica sobre este tema. En este número, intentaremos darles respuesta.

1. ¿La Iglesia apoya la política de "fronteras abiertas" y promueve la inmigración ilegal?

No. El Catecismo de la Iglesia Católica señala que "las autoridades civiles, atendiendo al bien común de aquellos que tienen a su cargo, pueden subordinar el ejercicio del derecho de inmigración a diversas condiciones jurídicas, especialmente en lo que concierne a los deberes de los emigrantes respecto al país de adaptación" (n. 2243). Esto incluye el derecho de cada país de asegurar sus fronteras.

Sin embargo, la Iglesia sostiene que dicho derecho no es ilimitado, sino que debe balancearse con el deber de recibir con caridad y respeto a los recién llegados. En su carta pastoral conjunta *Juntos en el camino de la esperanza*, los obispos de México y Estados Unidos identificaron cinco principios referentes a la cuestión migratoria que surgen de la Doctrina Social de la Iglesia (n. 33). Entre ellos, que "los Estados soberanos poseen el derecho de controlar sus fronteras" y que "las personas tienen el derecho de emigrar para mantenerse a sí mismas y a sus familias", al tiempo que reconocen que este último presupone la violación de un principio "ideal": "Las personas tienen el derecho de encontrar oportunidades en su tierra natal".
