OFFICE OF THE CHANCELLOR

SACRAMENTAL RECORDS: The information contained in the Sacramental registers relating to individuals is highly privileged. Sharing it with third parties is a violation of their privacy in both canon and civil law. For this reason, intentionally or negligently turning over Sacramental records could result in substantial trouble in civil (State) law. Pastors and parish secretaries may only issue copies of baptismal certificates, marriage certificates, and other Sacramental records for the individuals involved (named in the records) and at their own request. Of course, parents and legal guardians may request the records on behalf of under-age minors. Sacramental records may never be released to third parties (such as genealogy researchers, etc.). The only exception is to turn them over to authorized Diocesan personnel periodically for copying. There are absolutely no other exceptions. Any request for viewing Sacramental records outside these parameters must be brought to the prior attention of Rev. Keith Weber, Chancellor. His email address is keith.weber@salinadiocese.org.

SEMINARIAN COLLECTION: The seminarian collection is the weekend of August 8-9. Thank you for your support of this collection. Envelopes for this collection were included in the envelope boxes received by each parishioner.

The weekend of August 8-9 is the Annual Seminarian Collection. This collection was previously held in November, but as of this year, has been moved to August and is your opportunity to support the educational expenses of our seminarians. Currently, we are blessed to have eight men discerning a call to the priesthood. The cost to educate each seminarian per year is a little over \$50,000 per seminarian. The total cost to educate all our seminarians is almost \$450,000. Every gift to the Seminarian Education fund helps to cover the tuition, books and board and summer ministry expenses for our seminarians. Your generosity is a vital component to the success of these men as they prepare to minister to the needs of future generations of Catholics within our diocese. Again, this year, please process these donations as you normally would and submit the usual parish check to the Chancery. SEMINARIAN ANNUAL FUNDRAISING DINNER: This year's Seminarian Dinner that was scheduled for August 13 has been *CANCELED*. We are currently contacting all the registered guests to offer them a reimbursement. In place of the seminarian dinner, we will be releasing two brief videos on August 13. These videos will introduce the seminarians and the new co-vocations directors, explain the work of the vocations office, summarize the impact of a priest and the cost to educate and include a request for people to consider making a donation to the Seminarian Education fund. Additionally, it will include details of a matching gift. An anonymous donor has offered a \$20,000 match for the Seminarian Dinner. The gift will match every \$1 with \$1. Any gift designated to the Seminarian Dinner during the time-frame August 13 – September 15 is eligible to receive this gift.

Thank you for your understanding of this decision and for your help in promoting the upcoming videos.

#iGiveCatholic: Packets with information on the upcoming #iGiveCatholic campaign were emailed out on July 14. If you did not receive the information and would like to, please contact Katie Greenwood (katherine.greenwood@salinadiocese.org). Or let us know if you want a packet mailed to you.

The giving day is December 1, 2020 and advance giving starts on November 16.

Every parish, school, and Catholic ministry in our diocese is invited to participate. Watch your emails this summer for more information and an invitation to join us. Registration opens August 17 and closes October 31. **One big difference this year – you will need to sign up to participate.** Last year, diocesan organizations were automatically entered into the system. This year, those who do not sign up will not have a page on the iGiveCatholic website.

We have two confirmed matches.

\$50,000 match from 24/7 Travel Stores in support of Catholic schools and seminarian education
50 cents for each \$1 given, up to \$1,000 for a \$2,000 gift from a donor
Maximum match per organization is \$5,000

\$60,000 match from Phil Howe for Catholic parishes and schools in the Manhattan area
\$1 for each \$1 given, up to \$1,000 for a \$1,000 gift from a donor.

Some of our priests are already hard at work looking for local matches! If you would like assistance with soliciting a match or challenge for your parish or school, please do not hesitate to reach out to us.

SEMINARIANS THIS SUMMER: We were blessed to work with three seminarians this summer: Adam Zarybnicky, Brady Hutchison and Luke Friess. We are grateful for all their hard work. It was a joy getting to know these men.

ONLINE GIVING for PARISH SUPPORT: Back in late March, the diocese provided an online giving form thru our website for all parishes and schools in the diocese. This made online giving available to each of our 86 parishes and 15 schools.

OFFICE OF DEVELOPMENT (cont.)

Here are the outcomes of that work.

16 parishes had online giving before this action and these continue to use their system.

32 parishes reported they were actively promoting online giving through the diocesan website.

As of 7/28/2020, \$34,788 has been given to parishes through the diocesan website from 81 donors with an average gift of \$429.47.

The parish or school to support is chosen by the donor and 33 parishes have received at least one gift.

The largest single gift was \$2000.

Of the 81 donors, 32 (40%), made a recurring gift. (Recurring is a gift the donor sets up to happen repeatedly, such as weekly or monthly.)

This online gift form will remain on the diocesan website. If we decide to take it down, you will be notified in plenty of time to make the change.

CARES Act: As reported in an earlier SDNB, the CARES Act passed by Congress in the spring includes a couple items that may be favorable for charitable donations.

\$300 Tax Deduction for non-itemizers. All non-itemizers will receive a \$300 tax deduction on charitable gifts made up to that amount.

Charitable donation deduction increases to 100% AGI for itemizers. Congress has granted a charitable deduction opportunity, for those who itemize, up to 100% of AGI for the year 2020. There is also a carry-forward provision available for taxpayers who can't or don't need the full deduction in the year 2020.

Included with the SDNB, is an article written by a colleague from the Fargo diocese. It contains details and is a good reference for parishes and schools.

2020 ANNUAL FUNDRAISER: Thank you for your support of the 15th Annual Fundraiser, the Virtual Green Tie Celebration, which was LIVE streamed on July 18! CATECHETICAL SUNDAY: Catechetical Sunday will be celebrated Sunday, September 20, 2020. The theme will be "I received from the Lord what I also Handed on to You." All of your Religious Education Coordinators have received a Newsletter, and, in the newsletter, there is a Commissioning Service. There is also a special blessing that you can use to bless the parents since they really are the primary teachers in their child's life, and we need to consistently remind them of their important role.

Ideas for Stewardship, Tax Planning and Moving Forward in 2020

Despite the major interruptions the COVID-19 pandemic has caused, the vital work of the Church continues in our diocese, parishes, ministries, and the myriad of other programs. In the midst of all that is going on, many are looking forward to coming together inside the doors of our churches and once again experience the sacraments and fellowship with their Catholic family.

Meanwhile, Congress continues to respond to the pandemic with new legislation. The most recent piece of legislation is called the CARES Act. I would like to outline a few items in this Act that may favorably affect you or a loved one.

1. **\$300 Tax Deduction for non-itemizers.** So you don't itemize on your federal return? You are not alone. The vast majority (about 90%) of tax filers do not itemize since the standard deductions have increased so significantly. *But, with the new legislation in the CARES Act, all non-itemizers will receive a \$300 tax deduction on charitable gifts made up to that amount.* A tax deduction reduces the Adjusted Gross Income (AGI) that the federal government uses to calculate tax and determine which tax bracket you belong. For an individual in the 24% federal tax bracket, this will save \$72.

2. **Charitable donation deduction increases to 100% AGI for itemizers.** In a typical tax year, once a taxpayer's Adjusted Gross Income (AGI) is calculated, 60% of AGI has been the maximum amount of a charitable deduction available in that tax year. (For example: if an individual has AGI of \$75,000, then during that tax year, their maximum charitable deduction for donations made would be \$45,000). *However, with the new CARES Act legislation, Congress has granted a charitable deduction opportunity, for those who itemize, up to 100% of AGI for the year 2020.* There is also a carry-forward provision available for taxpayers who can't or don't need the full deduction in the year 2020.

Also included in the CARES Act is the waiver of Required Minimum Distributions (RMD) on IRAs for 2020. Even though RMDs are waived, you can still use your IRA to get a tax break on giving to charity. If you normally give to charity, do it with qualified charitable distributions from your IRA. The funds are directly transferred from your IRA to a charity, like your parish, and excluded from income. If there were RMDs, this would go towards satisfying the RMD, but even if there are no RMDs this year, this is a better way to give to charity and reduce your taxable IRA balance at the same time. Only IRA owners and beneficiaries who are age 70 1/2 or older qualify for this, though.

In February, I wrote about the SECURE Act. By far, most of the feedback I've had is regarding the children who are named beneficiaries on an Individual Retirement Account (IRA). In December, Congress passed the SECURE Act, limiting stretch payments to IRA beneficiaries to 10 years. If you

planned to benefit your children with your IRA, your heirs will now pay higher taxes on the inheritance they receive from you. *When you revisit your estate plan, consider funding a Testamentary Charitable Remainder Unitrust with your IRA balance.* This plan can provide lifetime payments to your heirs and spread out the taxes on their inheritance.

One further thought given the ups and downs with the current market. *Many in our diocese have found Charitable Gift Annuities a wonderful way to receive a guaranteed income stream.* A person might be surprised by the benefits. One can exchange low-performing stock, CDs or cash for guaranteed life-time fixed payments. If the person makes the gift of an appreciated asset, he or she will not have to pay capital gains when the annuity is funded. Also, Charitable Gift annuitants benefit from a tax deduction this year and a portion of the payments could be tax-free. APPLICATION FOR FUNDING

Application may be made once yearly – by September 15

Funds for the poor are available from two sources: The diocesan portion of the annual Catholic Campaign for Human Development collection and the annual Catholic Relief Services Rice Bowl Project. 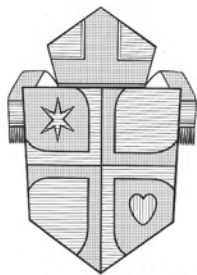

Reopening Parishes for Youth Ministry

NO EARLIER THAN IN ACCORDANCE WITH LOCAL GUIDELINES

Utilizing the following procedures, we hope to start once more working with teenagers and families, journeying with them in person, to Jesus through His Church. Our priorities are spreading the Gospel and stopping the spread of any contagions harmful to students or families. Only those who are participating in the celebration of Mass during the weekday or on Sunday will be allowed to participate in youth ministry. If you have discerned that you are unable to participate in the celebration of Mass because you are health fragile, then you should not participate in youth ministry.

Note that those highlighted in red are required; those not highlighted are recommended.

Prior to Engaging in Youth Ministry Events:

1. Signed Consent Forms
2. Cleaning/Sanitizing Common Space/Touch-Points
3. Event Temperature Checks
4. Possibly Covid-19 Testing if needed or required by various authorities

During Youth Ministry Events:

1. Social Distancing - min 6 feet between persons not of the same household.
2. No physical contact - touching , handshakes, hugs, roughhousing ect
3. Masks as required by local guidelines
4. Attendance Sheet/App to track participation.
5. Outdoors or in open public space is preferred
 - a. Indoor meetings require additional preventative steps for frequent sanitizing
6. Generally limit groups to no more than 10 teens/chaperons. May be adjusted as space allows or if using outdoor space - follow local guidelines.

Prior to Engaging in Youth Ministry Events:

Signed Consent Forms:

Each family should sign a consent form (one per child, one per volunteer or staff member) verifying that no one in household has any of the symptoms of Covid-19, and has had none over the last 2 weeks prior to attending the event(s).

- o Only one signed consent form per child per year is required.
- o If a minor attends an event without a consent form, a parent or guardian must be provided with an electronic copy of the consent form and give written permission for the child to participate.

Cleaning/Sanitizing Common Space/Touch-Points

- While surface spread of COVID-19 is less common than previously reported, continue to disinfect all common touch surfaces prior to the event.
 - o This includes, but is not limited to: light switches, door knobs, chairs or tables in use, microphones/audio equipment, etc.
 - Use an approved CDC disinfectant:

 - o “It may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes. This is not thought to be the main way the virus spreads, but we are still learning more about how this virus spreads.”

During Youth Ministry Events:

Social Distancing:

- Students will continue to socially distance themselves at events, especially when indoors or in enclosed spaces. Appropriate distancing will be based on the most recent recommendations from the CDC, state, or local health departments. At the time of this publishing, the current recommended distance is 6 feet.

No Physical Contact:

- Avoid physical contact with one another. This includes but is not limited to: hand shaking, hugging, fist bumps, high fives, or any games/activities where physical contact is required. This is believed to be the MAIN way the virus is spread, through close physical contact with an infected individual.

Attendance sheets/Apps:

- Staff are required to track attendance of all participants and acquire names and contact information (including contact information of parent/guardian in the case of minors). Proper care for participants requires that we know who is in attendance at all times. Individuals who

have experienced symptoms associated with COVID-19 are asked not to attend until they have been symptom free for 48 hours or have had a negative COVID-19 test result.

- o Ask anyone to not return to ministry events until after he/she has received a negative test result for COVID-19 or have self-quarantined for 14 days.

Outdoor Event Locations:

- Most Youth Ministry activities can be done outdoors. Whether games/activities, talks or witnesses, small groups or prayer/worship, all these can be done outdoors where there is the lowest chance of contracting or spreading the virus.
- With social distancing and holding events outdoors solely, (provided weather cooperates), you may minimize the chance of contamination.

Indoor Events:

Face Coverings/Masks:

- Guidelines for masks will be based on the CDC, state, or local recommendations. As the CDC revises recommendations for the use of masks, these recommendations will be updated accordingly.
- When indoors, students and chaperones should wear face coverings especially in small classrooms or youth rooms where social distancing is difficult.

Necessary Sanitation:

- All common touch points should be sanitized before and after each meeting.
- If possible, utilize larger classrooms or parish hall to allow for adequate social distancing.

- It is recommended that participants do not share materials (notebooks, writing implements) or personal items such as water bottles.
 - o Providing refreshments is not recommended.

Keep groups to no more than 10 to avoid crowded areas. This is more necessary indoors than outside.

Groups of 10 or Less:

- While not required, it is recommended that ministries limit small group gatherings to 10 people or less. Gathering in groupings of 30 or more can certainly make social distancing harder – especially in enclosed buildings.
- This restriction is consistent with the most recent guidelines for group gatherings issued by the Governor of the State of Kansas and those put in place by the majority of Kansas counties.

After Events of Ministry: Follow CDC guidelines to report anyone who shows symptoms or results in a positive Covid-19 test after an event.

Reporting if a Student, Chaperone or Staff Member shows symptoms or results in a positive Covid-19 test after an event:

1. Notify local health officials if a student, chaperone or staff member results in a positive Covid-19 test after an event. Maintain confidentiality as required by law.

- Advise individuals to follow CDC reporting guidelines should a person become ill and tell him/her to call his/her doctor.

Feedback/Adjustment:

- These recommendations will be reviewed and revised as necessary on a regular basis to ensure that they are adequate responses to changing conditions.
- Recommendations may be relaxed or increased based on the recommendations of federal, state, and local health departments.

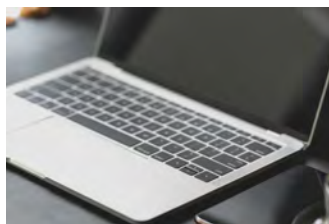
