VALUE THEM BOTH is the proposed state constitutional amendment for life supported by the Catholic Bishops of Kansas. The amendment is crucial because the Kansas Supreme Court recently created a nearly unlimited "right" to abortion, including taxpayer-funded abortion, teens seeking an abortion without parental knowledge or consent and late-term abortions. Once passed, the VALUE THEM BOTH will help protect mothers and their unborn babies from the abortion industry. Please pray for passage of VALUE THEM BOTH.

## PROPAGATION OF THE FAITH

**2020 MISSION CO-OP:** If your parish has not yet sent to the diocese the Mission Cooperative collection from summer 2020, please do so at your earliest convenience. Your prompt attention to this will help avoid confusion of the (summer) 2020 Mission Co-Op collection with the (October) World Mission Sunday collection (see below). Please also return the completed Mission Co-Op evaluation forms; your candid comments are very helpful in deciding which mission groups to invite back to the diocese.

**WORLD MISSION SUNDAY** is October 17-18, 2020. By now you should have received your mission information packet in your parish. The theme for this year's collection is "Here I am, send me!" Please display the posters and use any bulletin inserts to help promote this collection.

Please consider raising mission awareness through the entire month of October by including a mission-related petition in the General Intercessions at Mass. Some examples:

For a personal relationship with Jesus, God the Father's Own Missionary sent to us, that we may step out of ourselves for love of God and neighbor especially during this time of crisis, pandemic and need, let us pray to the Lord...

For our Holy Father, Pope Francis, head missionary of the Church, and for all missionaries and martyrs who give their lives to tell the glory of the Lord among the nations during the COVID-19 pandemic, that they may be loving, wise, and holy witnesses of Christ, let us pray to the Lord...

For an increase in missionary charity, that our spiritual and financial sacrifices may help the message and love of Christ be made known to the ends of the earth, let us pray to the Lord...

The Week Before World Mission Sunday (October 10-11): World Mission Sunday is next week! We are called through our Baptism to be part of the Church's missionary efforts, through prayer, self-sacrifice, and support of the Mission Church through material aid. This year, Pope Francis asks us to respond to that call, saying, "Here I Am, Send Me!" To "send" ourselves, we can: PRAY for the Church's worldwide missionary work and then OFFER financial help and charity through the collection for the Society for the Propagation of the Faith for vulnerable communities throughout Asia, Africa, Latin America and the Pacific Islands.

**For World Mission Sunday** (October 17-18): Today, on World Mission Sunday, we respond, "Here I am, send me," to our baptismal call to mission, and we offer, at the Eucharistic celebration, our prayers and our generous financial support, through the Society for the Propagation of the Faith, to continue the mission of Jesus. Today we are "sent" out to witness to mission in the world through our prayers and sacrifices for our brothers and sisters around the world. As little as \$25 helps support a catechist for a month in remote Latin America, \$75 provides for the work of religious sisters caring for orphaned children in Africa, \$100 assists families in sending their children to schools in Asia. As always, your prayers are your most treasured gift to the Missions. Your prayers and financial help, offered today, WORLD MISSION SUNDAY, support mission priests, religious Sisters and brothers, and lay catechists who are Christ's witnesses to a world so in need of His healing, love, and peace.

## **OFFICE OF RESPECT LIFE**

**2021 MARCH FOR LIFE IN WASHINGTON, D.C.** will take place January 29th, 2021. There will be a Salina Diocese sponsored pilgrimage again in 2021 but it will look different than past years. With uncertainty caused by the pandemic it was decided to NOT charter busses for the 25+ hour trip because confining a large group of people in a bus is not advisable at this time. The alternative to riding the bus is to fly to D.C. or drive yourself there! Airline tickets are currently priced at an affordable rate, but that will change quickly as the January event date draws closer. The Diocese **WILL NOT** purchase airline tickets, that is up to each individual or group to do on their own. The Diocese **WILL** provide hotel accommodations and transportation in D.C.!

The itinerary will look very different this year as well. Many of the activities such as the evening rallies and Mass with the other dioceses of Kansas are unlikely to happen. The pilgrimage will focus on the March itself and will still include a visit to the Basilica of the National Shrine of the Immaculate Conception, but other activities will be limited.

Plan on making travel arrangements to arrive in D.C. late afternoon/evening on Thursday, January 28th and depart from Reagan National Airport after 2:00 p.m. on Saturday, January 30th.

Expected cost per person for hotel and transportation in D.C. is \$200. The DEADLINE to register is NOVEMBER 20th, 2020 with two ways to register. Online registration is available, or you can mail in your registration. Full payment of \$200 is due with your registration. Make checks payable to Salina Diocese Respect Life Office and mailed to PO Box 980, Salina, KS 67402, attention: March for Life. Cost of travel must be paid by the individual. Registration forms, Medical/Waiver forms, are available on the diocesan Website.

ALL plans are subject to change as the ongoing pandemic makes it difficult to be assured of anything. When purchasing airline tickets be sure to ask about refundability or transferring the use of your ticket to a later date in the event we don't go.

As we begin this month of October, I ask each Safety Coordinator to take time to reflect on the start of the new school year. You may be the safety coordinator or principal of a school, or possibly the safety coordinator and catechist at your local parish. In your town, students may be going to school for in-person classes. In another town, students may be at home engaged in some type of remote learning. Whatever it may be today, it will likely change tomorrow.

You secured your volunteers for religious education classes, and they are current in their safe environment training and background checks. You are familiar with the new driving guidelines for parent drivers at our Catholic Schools. You have chosen what safe environment curriculum you will use with your students. You have visited with parents on the roll they will have in educating students this year, in some cases, parents will be teaching their children at home. You have turned in your certification status forms to the Safe Environment Office. You know precautions to take when using the Zoom platform to ensure that on-line ministry is both safe and holy.

You have purchased thermometers, masks, hand sanitizer, and Clorox wipes. You have asked the advice of everyone possible (and yes, everyone's answer was different). The road has been bumpy, but you press on.

Praise yourself for all the hard work you have done to get this far ensuring that the return to school and parish activities are safe, efficient and seamless for our children.

But, as staff and students return to school, **child abuse disclosures and reports will likely increase**. According to the US Department of Health and Human Services' 4th National Incidence Study of Child Abuse and Neglect, **teachers** identify and **report** more child abuse cases to child protection authorities than any other professionals-including doctors, hospital personnel, police and social service agencies.

As you continue the daily trials, being aware of these challenges and many others, along with the need to be flexible, and understanding, know that you are truly making a difference in the lives of your students. Your students need you and depend on you to provide an environment that is safe and healthy, ( sometimes home is not a safe and supportive environment) not only during this unprecedented time, but every single day. Thank you for the work you do, as we continue our mission; promise to protect pledge to heal.



Reflection: God of love, we recognize Your presence in our journey together as we gather here for the start of this year in Your name. Open our minds to know Your voice. Open our hands to do Your work. And open our hearts to hold Your spirit. Amen

A reminder to all Safety Coordinators of Schools: A new process has been implemented (in addition to diocesan guidelines) for drivers who transport minors in their own private vehicles. These guidelines were sent to all principals through email. If you have any questions regarding this new process, please contact Geoff Andrews.

As part of our efforts to protect minors, the Diocese of Salina requires Safe Environment compliance on a *five-year cycle* for clergy, employees, and all volunteers working with minors. Safety Coordinators please be sure you are monitoring the CMGConnect data base *weekly* to ensure that all those ministering are in compliance, and if they are expired that they renew promptly.

**I have received a few questions on how** to proceed with the requirement of signing the "Acknowledgment Form/Appendix E". If you need suggestions on how to complete this new standard at your parish or school, please let me know.

The updated Safe Environment Program was distributed to parishes and school in July. If your parish or school did not receive a copy, please let me know. In the program, there is a section called *Frequently Asked Questions* that you may find helpful as you remain committed to ensure the safety of children and young people, who have been entrusted in our care in our parishes, schools, religious education classes, and other programs in our communities.

An on-line *survey* was emailed to *PARISH* Safety Coordinators at the beginning of September. If you have not filled it out yet, please do this by October 15th. I am trying to gather information from Safety Coordinators in terms of when and how (in-person, on-line, at home) they are starting Religious Education classes and how it relates to the Safe Environment Program. A big shout out to those who have already filled it out. Your feedback is very important as we continue to muddle our way through this pandemic and continue our mission; promise to protect, pledge to heal.

**The Diocese of Salina** will be launching a new website in October. I saw a sneak peek and I am sure you will find it visually appealing, user-friendly, and informative. The actual process should be seamless, but, please feel free to contact me once it has been launched if you can't find a particular "*safe environment document*", or you have any questions.

**Finally,** You have spent the last few months preparing to start school and begin religious education programs. You have implemented COVID safety measures to keep children safe and healthy and implemented the guidelines in the recent updated Safe Environment Policy regarding strategies and prevention of child abuse. This pandemic has turned our own personal lives upside down, everyday is a new challenge, you are overwhelmed, stressed, and exhausted. Try to take a break from the stress (turn off the news or take a break from social media) and engage in a healthy, soothing distraction. Pursue things that give you joy and hope. While this pandemic continues, draw on some personal strengths that have helped you in the past. Stick to your routine and seek support if you need to.

## **IMPACT OF COVID-19 on CHILD ABUSE** Considerations for 2020-2021 School Year

## For Some Students:

- home is not a safe and supportive environment.
- may have faced neglect or abuse as a result of being in close proximity to caregivers for extended periods of time (without physical interaction with their service providers or schools.)
- the economic strain of the pandemic and mental/emotional strain can lead to an increase in violence in the home,
- including domestic violence and child sexual abusethey had different caregivers.
  - -Grandmom is high risk for infection, so teen neighbor has been watching them. -Mom and/or Dad may be essential workers, so Uncle Bill has been coming over to the apartment.
- May lack access to food, shelter, friends, or support.

## **RETURNING TO SCHOOL**

While delayed disclosures are common among children, disclosures could increase upon return to school, BUT forensic interviewers say that disclosures could be delayed by an additional 6-9 months.

## **Student Concerns May Be:**

- Should I be talking about this with all these new rules? Washing hands, masks, temperature taking, social distancing
- Need to focus on learning. Missed so much school. Should focus only be on learning?
   Neuwran pow tacchar?
- 3. New year, new teacher? Is new teacher a Trusted Adult?
- 4. With social distancing restrictions, can I get close enough to tell the teacher I need to speak to someone privately?
- Availability of one-on-one access?
   Existing Policies & Procedures/New Social Distancing guidelines
- 6. Who do I talk to? New school year/new grade level/maybe new school?

## **Suggestions for Teachers:**

Quick Refresher for teachers on mandated reporting. Warn teachers that trauma from abuse may increase due to:

- Isolation of Staying Home
- Fear of threats not to tell
- The act of abuse
- Home discourse/stress







**Related Issues** 

1.5 Billion Students worldwide have been home from school since March 2020; many will continue to be.

- More children active online and on social media as a result of isolation.
- Much time online unsupervised
- Global reports of suspected abuse to NCMEC's Cybertipline up 106% compared to March, 2019.
- 89% fewer child abuse images removed from Internet
- Knowing this, distributors using mainstream platforms, grooming & exploiting kids, 90% new images are GIRLS. NCMEC = Nat'l Center for Missing & Exploited Children

## Insight from Child Advocacy Center\*

Majority of child abuse reports come from schools.

Covid-19 school closures impacted reports: April, 2020 – down 75% May, 2020 – down 50% Summer – typically low because kids are not

connected to teachers/school support

- Most forensic interviews happening right now are delayed disclosure from past abuse (months or yrs)
- Increased forensic interviews of teens sneaking out to meet older guys in their 20's and experiencing sexual assault.

## **Recommendations for Helping Students**

- Announce availability of help for any student.
- Specifically mention neglect, physical abuse, sexual abuse, food & housing insecurity.
- Introduce the person to whom students can talk;
  - If wearing masks, may want to introduce the person (counselor, nurse) behind glass window without mask on, or have the adult hold up a photo of themselves w/o a mask on.


- Much friendlier face without the mask on – and the child can make the connection to the "friendlier face".



- Conversely, teens seem to take comfort in the semi-anonymity of mask wearing during disclosure/forensic interview.

- Let students know school staff is there for them right now and at any time in the future.
- If something did happen to a student during COVID-19 Stay Home/Stay Safe, let them know: - they are not the only one and it was not their fault.
  - caring adults are available to help them feel safe again and begin to heal.
